The Honourable Peter Kent was first elected to the House of Commons in 2008. Following his election, Minister Kent was sworn into Cabinet as Canada's first ever Minister of State of Foreign Affairs (Americas).

In January 2011, Minister Kent was appointed Canada's Environment Minister, responsible for the Meteorological Service of Canada, Parks Canada, the Canadian Environmental Assessment Agency, enforcement of the Species at Risk Act, operation of the Chemical Management Plan, development of Canada's domestic Climate Change mitigation and adaptation policies, and the international negotiation of a more effective, post-Kyoto Protocol climate change regime.

Prior to his election to the House of Commons, Mr. Kent was a broadcast journalist having spent more than 40 years working as a writer, reporter, producer, anchor and senior executive in Canada, the United States and around the world. Minister Kent won a number of awards over the course of his career for his insightful reporting, including the prestigious Robert F. Kennedy Award. He is also a member of the Canadian Broadcast Hall of Fame.

A passionate believer in community involvement, Minister Kent actively supports a number of charitable organizations, such as the Toronto Region Immigrant Employment Council, the Toronto Conservatory of Music, Friends of Simon Wiesenthal Center, and the Sunnybrook Health Sciences Centre.
